The reported values for Muscimol may be inflated by the presence of Ibotenic Acid and/or Muscarine in the sample. Method validation is in process to accurately identify Ibotenic Acid and Muscarine. In addition, throughout our method validation process we have observed possible inhibitory effect of water with Muscimol. Water was utilized to dissolve the gelatin in the sample and may inhibit the absorbance of the target analyte Muscimol. Reported amounts for Muscimol may be lower than the actual amount in the sample.

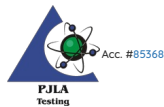
